Cutting it thin (or, seeing the light)

Len Brissette joined the list of first-time demonstrators that **Dave Dick** has brought to us this year, by showing us how to turn a hat out of green wood. Len began by showing us examples of full-sized hats that the has made, some more successful than others. He then showed examples of miniature hats that he had turned using the same techniques. In the interest of time, he elected to turn a miniature hat in his demo.

Len emphasized that it is very important to use freshly cut wood and to keep it moist so that is pliable and doesn't crack while you are turning it. He uses diluted laundry bleach in a squirt bottle to keep the piece damp.

Miniature hats can be made any size. But for a full-size, wearable hat the interior hat band size is critical. The hat size with which we are familiar is a combination of the length and width of your head. Specifically, you add the width of your head to one half the difference between the width and length. For example, if the length of your head is 8 inches and the width is 6 inches, your had size would be 6 plus one half of eight minus 6, or one. Thus your hat size would be 7. This, then, is the diameter of a circle of cloth which would fit comfortably around your head.

When turning a hat, you start by turning the outside. The outside hat band measurement would be your hat size plus twice the thickness of the hat band plus a small allowance for shrinkage, or about one quarter inch. So, in the example above, you would measure 7 plus 1/4 plus 1/4, or about 7-1/2 inches. The actual shape of the hat band will be controlled during the drying process by placing the hat in a press and forcing it into an oval to fit your head. We didn't get any photos of the hat press, but it you are going to try this yourself, you might want to get with Len and get the design.

Len chose a freshly cut piece of hackberry for this demo. In view of its small size, he brought the tail-stock up to press the piece against the Stronghold chuck used as a friction drive. He estimated the center by checking the clearances of the corners of

the block from the tool rest. Using a bowl gouge, he proceeded to turn a tenon on the outside and rounded the piece and checked for cracks and the general shape. Then he cut the outside to the band diameter. When the band diameter was set, he then began to shape the hat from the tenon (which will become the crown) down, leaving a 1/32" relief for the band. He then began to shape the top of the brim, thinning from the outside, with a light shining through to allow using the translucency to judge thickness.

At this point, Len reversed the piece and chucked it to finish thinning the brim. A drill bit is used to establish the depth of the crown. He then hollowed and thinned the crown, using a light to judge thickness, until he could see the band from the inside. He then continued to thin and clean up the inside top of the crown with a hook tool.

At this point, he again reversed the piece into a shop built drum chuck, with a shop built light going through the head stock and turned the outside of the crown to thickness.

All in *all a tour de force* for a first time demonstrator on a difficult project. Thanks to Len, and we look forward to his next demonstration.

Register early for Lyle Jamieson sessions in March, 2005

You are reminded again that Lyle Jamieson will be here to conduct demonstrations and hands-on sessions in Austin in March, 2005. Lyle is a world renowned turner of hollow form sculpted pieces. Stacey Hager describes Lyle as one of the best teachers of turning he has ever studied with, on the same level as Stuart Batty. Details of both the two days of demonstrations and the two-day hands-on session can be seen in detail at www.lylejamieson.com/instruction-classes/index.asp.

There will two days of demonstrations, March 12 and 13, at American YouthWorks, our regular meeting site. These will run from 8:30 to 4:30 and will cost \$30 per day. We need at least twenty people each day to break even for the event. This will be followed on Monday, March 14, by one (or two, depending on the preference of the people participating) day(s) of hands-on instruction for five or six people. These sessions will be held in Charlie Kay's shop (bring your own lathe) and will cost \$100 per day per participant. The topic(s) for the hands-on sessions are yet to be determined, but probably the first day will be on basic skills (see website, above) and the second day, if there is enough interest, would probably be on hollow form turning. In addition, Lyle is available on March 15 and 16 for detailed individual instruction for one or two turners at a special rate of \$250 per day.

Ho Evans has again graciously consented to handle registration and arrangements for the sessions. The prices above are set to cover the basic costs of the events. If we get more participants, we are suggesting that any funds received over costs should go to the lathe fund.

Mark your calendars and get in touch with Ho and get your name on the list. We will be publicizing this to other clubs in the area and inviting their turners to join us for these events. We would appreciate those of you who are interested in participating seeing Ho and getting your money in early.

Interested in a CTWA Tool Exchange?

I am proposing that we set up a table at the monthly meeting for exchanging items. For lack of a better name I would call it a Swap Table. I believe that we should limit the items to be exchanged to those related to woodturning and woodworking. This obviously could be very wide ranging, but should be a good broad guide. The Swap Table would include items for sale (i.e., items swapped for money), exchange (equal trades or with kicker) and give-a-ways. I have many items that I moved from Minnesota that I don't really have any use for, but they have value and are of good quality, so I couldn't throw them away. I would give some of them away if I could find a person who would use them. Donations to the charities are not very beneficial to either party on many of these things. A transformer is an example. I considered selling it at a garage sale or on E-bay, but both have more negatives than benefits. The CTWA membership is a great group that might benefit from things that we all have and are willing to part with if we had a medium to make the exchange feasible at a reasonable investment. I think the Swap Table would benefit all of us. Since it is a free market, I have no concern about price or activity. Some things could be donated to the club and sold so the club would also get a benefit. I envision tools of all shapes and sizes (i.e., lathes), fixtures, turning stock, sandpaper, finishes, etc. I have some new parts bins that are to expensive to ship compared to the value if I sold them on E-bay, but if I could get a few bucks for them at the Swap Table and someone carried them home, we both would benefit. I don't think the club should try to get a commission or rent/sell space. We could suggest donations from the benefit. I also think that participation ought to a privilege of membership. We presently lack a way to get people to go from visitors to membership. This would be one way to benefit members and encourage visitors to join.
